Spring SOS By Mike York

The SOS Festival is a semi annual extravaganza that continues to grow each year. This week long Mecca for Beach Music happens every fall and spring at the shagging shrine....The Pad at Ocean Drive, SC.

Last spring as Gwen and I approached this tiny village beside the sea we spotted thousands of people milling around Ducks, Fat Harold's and the Spanish Galleon. I rolled the car windows down at the only stop light in town and immediately inhaled that salty breeze and heard the nostalgic sounds of beach music. We had arrived! What a place! What a feeling!

Gwen and I never seem to have enough time for shagging and watching serious shaggers. We hadn't really planned to take the time to go to this year's SOS until we began to hear irresistible descriptions from 106.5, North Carolina's beach music radio station! After hearing a conversation with professional shagger, Charlie Womble, broadcast live from the festival I gave in and called a realty company. Some accommodations were still available at near by Cherry Grove Beach.

There are many of us in the Carolinas who participated in the beginning shag. It is danced to a specific beat that originated from rhythm and blues songs played by mostly black musicians in the late fifties. Some of these old songs such as "60 Minute Man", "Miss Grace" and "Work With Me Annie" are classic that will never be forgotten!

Shagging clubs have been popular in the Carolinas for years. New clubs are beginning to spring up outside these two states. Gwen and I saw shagging club shirts with logos from as far away as Orlando, Fla. According to a special editions of "The Sand Flea" - the Society of Shaggers, SOS, has 58 shag clubs, with membership at around 12,000.

Shagging is a truly Carolinas' phenomena. It is modeled after the jitterbug, a dance that probably originated up North. In the South we are laid back and slow moving. Aren't all Southerners considered cool and smooth? We don't like to see people jumping up and down and out of control on the dance floor. Shagging is done with very little upper body movement and plenty for fancy foot work. The Belly-roll and the Sugarfoot are a sight to see. When Shagging is practiced and refined by experienced dancing couples, it is very beautiful to watch!

#### BYLAWS OF THE BURLINGTON SHAG CLUB

ARTICLE 1

NAME

The name of this club is the "Burlington Shag Club".

ARTICLE 2

OBJECTIVE

The objective of the club shall be the preservation of the Shag through sharing the enjoyment of the dance with others in a friendly and family oriented atmosphere. This is a not for profit organization.

#### ARTICLE 3

**MEMBERS** 

Section 1. The membership to the Burlington Shag Club shall require a person be at least 21 years of age and of good character.

Section 2. All prospective members must be sponsored by a member in good standing. Dues must be paid prior to declaration of membership.

Section 3. A club member who has been determined undesirable by the Elected Officers can be removed from the membership by a 2/3 vote of the members present provided the member has been notified in writing at least one week prior.

Section 4. The club dues shall be set from time to time. The club year shall be January 1 to December 31. All members whose dues are more than two (2) months arrears shall be automatically dropped from the club membership.

#### ARTICLE 4 ORGANIZATION STRUCTURE

Section 1. The Officers of the club shall be: President, Vice President, Secretary, and Treasurer elected from the general membership as prescribed by these bylaws and by the parliamentary authority adopted by the club.

Section 2. The parliamentary authority for the club shall be Robert's Rules of Order.

Section 3. Duties of the Club Officers:

#### A. President

- 1) To open all meetings at the prescribed time and place.
- 2) To conduct all business before the club.
- 3) To restrain the members when engaged in debate within the rules of order.
- 4) To authenticate, by signature when necessary, all acts, orders, contracts and checks of the club.
- 5) To stand for the club, declaring the club's will and in

all things, obeying the club's commands.

6) To adjourn any meeting where order cannot be maintained.

7) To preside over the general election of officers.

8) To serve Ex-officio on all committees.

9) To appoint any special committee deemed necessary.

B. Vice President

1) To assume the duties of the President in their absence.

2) To act as coordinator between committee chairs.

3) To establish new ideas for the club.

4) To help form all committees.

5) To be in charge of the club Ways and Means.

C. Secretary

To take minutes of the club meetings.
 To read minutes of the previous meetings.

3) To conduct all club correspondence as directed.

- 4) To maintain a file of all club correspondence, minutes,
- 5) To maintain a list of club officers, committee chairs, committee members and club members.
- 6) To call meetings to order in the absence of the President and Vice President until a pro-tem can be elected. The election shall take place immediately.

D. Treasurer

- 1) To receive and bank all club monies.
- 2) To keep bookkeeping records for all funds.
- 3) To dispense all money as the club may direct.

4) To give monthly financial reports.

- 5) To give a complete financial statement at the annual meeting.
- 6) To insure all checks are approved by the President.

Section 4. Officers shall be nominated, by secret written nomination, from the general membership, at the  $\hat{J}$ anuary meeting and elected by secret ballot at the February meeting. begins at the close of the February meeting.

Section 5. No member shall hold more than one (1) office at any one Officers of the Burlington Shag Club shall not hold an office in any other shag club.

Section 6. Any officer missing three (3) unexcused business meetings shall be removed from office. The President shall upon approval of 2/3 of the members present appoint a new officer to complete the term.

#### ARTICLE 5 MEETINGS

Section 1. The regular meeting in February shall be known as the Annual Meeting and shall be for the purpose of installing new officers and receiving the annual reports.

Section 2. The regular meeting of the club shall be held on the third Friday, at 7:30 PM, at a place agreed upon by the members once monthly.

Section 3. Special meetings may be called by the President, or by written request of at least ten (10) members. Three (3) days notice must be given for special meetings, except in case of emergency.

ARTICLE 6 QUORUM

A quorum shall be considered to be present when twenty (20) or more members are in attendance.

ARTICLE 7 CLUB MONIES

Section 1. Definition: All monies ie. dues, donations, committee funds and equipment.

Section 2. Disbursal are to be made by the club Treasurer for all proven debts. All checks issued must be signed by the club Treasurer or President.

ARTICLE 8 COMMITTEES

Section 1. The Committees of the Burlington Shag Club will be as follows:

- A. Entertainment Committee
  - 1) To be staffed by club members on a volunteer basis.
  - 2) Elect a Chairman and a Co-Chairman from the group.
  - 3) To plan and implement (after approval of the members at the General Meeting) all the clubs functions such as the Luau, Shag for Hearts, Christmas Party and any other event they would like to present. This requires all necessary arrangements to be made.
  - 4) To see the tickets for the said event are available and distributed to the club members to be sold. Not all of the club members will be available for ticket sales. This includes the tracking of the ticket numbers (if required).
  - 5) To use the Telephone Committee to help promote and distribute the tickets to the club members.
- B. Golf Tournament Committee
  - 1) To be staffed by club members on a volunteer basis.
  - 2) Elect a Chairman and a Co-Chairman from their group.
  - 3) To plan and implement (after approval of the members at the General Meeting) two or more Golf Tournaments per year.
  - 4) To see the tickets for the tournament are available (if required) to the members and quest.
  - 5) To make all the necessary arrangements with the Golf Course to be used.
  - 6) To use the Telephone Committee to help promote the event.
- C. Telephone Committee
  - 1) To be staffed by club members on a volunteer basis.
  - 2) Elect a Chairman and a Co-Chairman from their group.

1) To be staffed by club members on a volunteer basis.

2) Elect a Chairman and a Co-Chairman from their group.

3) All other Committees will contact the Chairman of the Telephone Committee if their services are required. The Committee requesting telephone help will be responsible for clear instructions as to what is expected of the Telephone Committee.

4) To divide the membership list among the Telephone Committee (will be the responsibility of the Chairman).

5) It will be the duty of each Committee member to call the members assigned to them. If there are Long Distance calls to be made, assign them to one person. They will be reimbursed for those calls.

#### ARTICLE 9

#### AMENDMENT OF THE BYLAWS

These bylaws may be amended at any regular club meeting by a vote of 2/3 of the members present, provided the amendment has been submitted in writing at the previous regular meeting.
