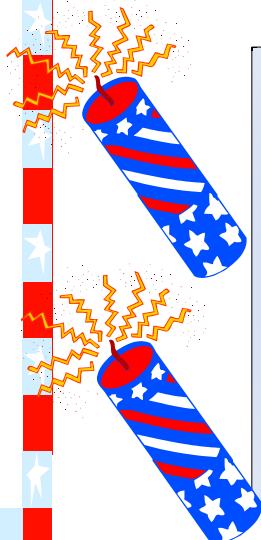

**By Laws:** Sheila Walker was chair of the committee that was reviewing the by-laws to clarify our membership dues. The following are the recommendations that came from that meeting:

**Membership Dues, page 1 of the current by-laws:**

Verbiage of Membership sections letter D and E were reviewed with the recommendation to insert an additional letter moving each of the following down to the next letter as listed.

**Adding a letter to the Membership section for Letter D, reading as follows:**

**Current By-Laws Reading:**

**D. The club will re-evaluate the dues from time to time. The club year shall run from January 1st through December 31st. Memberships purchased on or after November 1st of the said year will be effective through the following membership year. The club will automatically remove any member from the roster whose dues are not received by February 1st. Dues renewed after February 1st will incur an additional \$5.00 charge.**

**Recommendation:**

**D. New membership or renewal membership to the BSC will pay a membership fee of \$15.00 per person for a one year membership to go from January 1<sup>st</sup> through December 31<sup>st</sup> if paid by February 1<sup>st</sup>. Payment is required by February 1<sup>st</sup>. Any membership purchased after February 1<sup>st</sup> will incur an additional \$5.00 charge. New Membership is defined as anyone who was not a member the previous year of the year of their purchased membership.**

### **Current By-Laws Reading:**

**E. The club will waive the additional charge for late membership renewal if the re-up party is postponed due to uncontrolled circumstances. Additional charge will then be incurred if dues are not received by the conclusion of said party.**

#### **Recommendation:**

**F. The club will waive the additional charge for late membership renewal and new memberships purchased if the re-up party is postponed due to uncontrolled circumstances. Additional charge will then be incurred if dues are not received by the conclusion of said party.**

**The committee was asked by the officers to review the following sections for clarification.**

### **Duties of the Club Officers:**

Under the duties of the club officers on page 2 of the current by-laws, it is recommended to include the following as the first statement prior to individualizing each office:

**To host and choose the type of membership appreciation party to be held in August.**

#### **President's duties**

Add a letter for h and drop everything else down in order beginning with the next letter.

**h. To appoint a chairperson to each committee that will be staffed by three (3) or more additional BSC volunteer members.**

The additional information this committee was asked to review is listed under the DJ Committee section number 2. The payment for DJ services is not discussed in the current By-laws. The addition of the following is recommended.

**DJ Committee, page 5 of the current by-laws:**

#### **Current Reading:**

**2. To schedule DJs for regular dance nights.**

#### **Recommendation:**

**2. To schedule DJs for regular dance nights at a fee of \$100. To schedule DJ's for special parties as outlined in number 3 of the DJ committee duties for \$200.**

#### **Current Reading:**

**3. To have chairperson canvass membership at a regular business meeting for DJ recommendations and to choose from the recommendations based on DJ availability for special parties, i.e. the Area Shag Club, Christmas, Membership Appreciation and Benefits.**

#### **Recommendation:**

**3. To have chairperson canvass membership at a business meeting for DJ recommendations for special parties, i.e. the Area Shag Club, Christmas, Membership Appreciation and Benefits. The membership will then vote for a 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> option from the recommendations. Based on the recommendations, the top three options will be contacted for their availability and report back to the membership the name of the DJ who is to play. In the event the first choice is unavailable, the 2<sup>nd</sup> choice will be contacted for availability to play and then the third if needed. The membership will be informed at the next business meeting**

**Charitable Fund Raising Committee, page 5 of current by-laws:**

#### **Current Reading:**

**4. To be responsible for the planning and implementation of all aspects of the charitable event.**

#### **Recommendation:**

**4. To have chairperson canvass membership at a business meeting for Band recommendations for Charitable 89 Benefit parties. The membership will then vote for a 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> option from the recommendations. Based on the recommendations, the top three options will be contacted for their availability and report back to the membership the name of the Band who is to play. In the event the first choice resigns from the function, the 2<sup>nd</sup> choice will be contacted for availability to play and then the third if needed. The membership will be informed at the next business meeting.**

will be used for our adopted Christmas Cheer families.

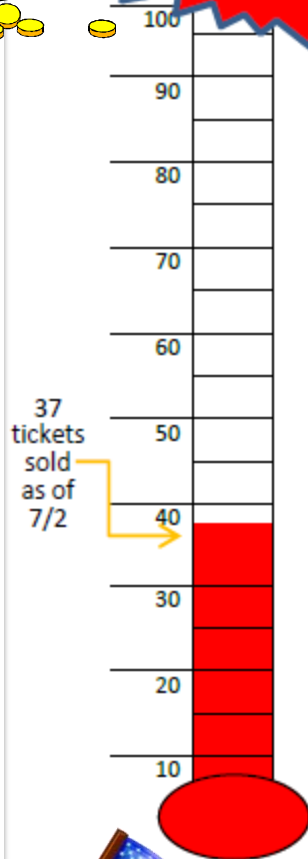
