Treasurer's Report: Amy Crawford presented the 7/20/12 YTD treasurer's report. Our current balance is \$1123.14. Cindy Swiggett made a motion to accept the report and David Sims seconded. All approved.

Luau: Amy thanked all those who help in set up, working and clean up. Many compliments from other clubs and visitors and now more and more people have express interest in attending.

Special Olympics Golf Tournament: Stephen Stearns reminded everyone of the next meeting on 7/25/12 at Master's at 7:00 PM. Also, still needs items for the raffle and they are working on gift bags and other items. Remember that we will need individual desserts provided by the members. Evelyn Turner passed around the graphic for the corn hole design that will be raffled off at the tournament. The materials are being donated by Baxter Sellars, with Joe Davis doing the construction. Lee Neese and Rick Turner are doing the basic painting and finishing, with Sherry Tyndall volunteering to paint the graphic for us. Evelyn is producing the bags. She has tickets (packets of 20) that need to be sold. If you get these and sell your 20, your name will go into a drawing for dinner at Ramada, a gift card for Cancun restaurant or to win a wine bag with your choice of design on it. Tickets are \$5.00 each, so see Evelyn after to meeting to get your tickets to sell or to buy them. All proceeds will go to the Burlington Shag Club. Pam Hord also suggested the possibility of having a workshop to make more of these to see. This is something that we will look into. Dianne Neese reminded everyone that if we want to continue to meet every Friday night and dance; we need to step up and buy and sell these tickets!

Qdoba shagging demo event: Charlie Brown has asked us to come out to Qdoba at Alamance Crossing on Saturday, 7/28/12 from 12:00-2:00 PM to demonstrate shag dancing. Joan is encouraging lots of us to come out since Qdoba has agreed to donate gift items for the golf tournament and the MOW. Let Joan know if you can come out and dance, but come out and support the club for as long as you can during that time.

Website: Joan stated that during the last ACSC meeting in Jacksonville, FL, the clubs were reminded to be careful what we put out there on our website. We do not need to have our by-laws or our financial reports out there for everyone to see. The Board of Directors has voted to remove the by-laws from the site.

Fun Monday: Cindy Swiggett asked that everyone see her with your ideas for selling items at Fun Monday and to volunteer to work that Monday or for the committee. Please come out to the tent on Fun Monday and purchased items and raffle tickets to the corn hole set we are making and raffling.

Board of Directors Meeting: Per Edith Loy, the board met at K&W Wednesday, 7/18/12 at 6:30. Judy called the meeting to order at 6:35.

Joan told us that at the ACSC meeting in Florida last weekend liability issues were discussed at length. We are covered on most events we have except the golf tournament where we furnish beer. North Carolina has a dram-shot law which states that social clubs can be held responsible for any liability which occurs where alcohol is given out. Joan and Stephen consulted with an insurance company and a lawyer. The club could purchase a one day policy for \$700 or the club could write a disclaimer waiving the club of any liability resulting from giving out alcohol. This disclaimer is not 100% foolproof. It could still be challenged in court if there was an accident and alcohol was a factor.

Fun Sunday: Remember that we have the Coalition Party on the beach on 9/16/12.

Business Meeting 7/20/12 (cont'd)

Status of the club:

Joan Kimbro addressed the members of the club that were present by asking each of us to hear her out and save any questions and/or discussions for afterwards. Joan stated that shag clubs have turned into a "business" more than just a social club established for fun. There are new concerns with liability, especially for free pours or events where the shag club provides alcohol to those in attendance. She also apologized for not being on top of the finances. In 2006 our club hosted the summer ACSC Workshop and was able to walk away with over a \$12,000 profit. Having this money gave our club a great nest egg and as years past with other monies received from 50/50's and promotions, our club has managed on dues alone. However, at the beginning of 2010, we only had a little over \$4000.00 left in the treasury. This past January, we took in \$2205.00 in membership money and spent \$1398.18 on the re-up party on free alcohol and food. That means that over ½ of our \$15.00 annual dues taken in that night were spent on the re-up party. That left revenue of only \$806.00. With 50 weeks of DJs this year for a total of \$5000.00 and another \$400.00 for DJs for special parties Add to that the ACSC dues, meetings and other obligations, it's apparent that we cannot operate on \$15.00 in annual dues per person and continue to spend like we have in the past. The current dues do not cover our monthly obligations which add up to about \$14,000.00 per year. We will have to increase our dues or find ways to cut expenses. Selling tickets for 50/50, raffles and sweepstakes are our only options for earning extra funds. When we don't have people stepping up to sell or buy these tickets, we can't make the money needed for the club. We can't continue as a club if we are not putting money back in to the club. We don't charge a cover charge every Friday, as many clubs do, but we continue to have a DJ every Friday night. She understands that people are tired but we aren't getting the participation that we need and the same people are doing most of the work. We sell 50/50 tickets at each meeting, but if members are not coming out to the meetings, they can't buy a ticket, therefore less money going back into the club. (Secretary's Side note: with only 43 members present at this meeting, that is only 16% of the membership in attendance). The Luau didn't make a large amount of money. The Coalition determines what the door price is. We couldn't keep working the same people in the kitchen and having them pay to get in, work the entire evening on food prep, serving and clean up and not be able to participate in the activities. The same ones were doing this each year. No one volunteered to take that over, so we decided to cater the food. Having the meal catered does not allow us to make much, if any money on the door. The Moose has also levied an additional fee to use the kitchen if we decide to prep food there. Only \$800.00 was made on the 50/50 and sweepstakes sales. We have to participate, volunteer and purchase tickets. We will NOT let this club fail! We are the 6th largest club in the association by membership. We have so much potential and need to come together and move forward and prosper.

With Fun Monday coming up, we have an opportunity to make some money for the club. We have come up with some ideas and have some items that have been donated to us to sell. But we need ideas on what to sell and for folks to sign up and come out and man the tent and work the crowd. Joan stated that she appreciates all of those present for coming out to the meetings, but reminded everyone that we either do more to help the club or raise the dues. One of the current by-law suggestions for review states that the club has to provide a membership party, but this can't be approved as written. It should state as funds are available. We do so much for MOW, Special Olympics and Christmas Cheer; however, none of these monies come to us. Speaking of Special Olympics, it was decided that we would not provide free beer to the players or others present. We need to protect our club from lawsuits should anything happen. Beer can be purchased from the clubhouse or the players can bring their own. We will provide soft drinks and water only. The Dram Shot Law holds us responsible if something happens to someone after leaving an event where we provided the alcohol. Joan said that she reviewed this issue with several attorneys and insurance agents and if we purchased one day event coverage it would cost us \$700.00. We asked Special Olympics if they wanted to purchase the policy instead and they declined stating that they didn't want to cover that costs. We also looked at having the participants sign waivers, however, there is no guarantee we would be covered. We could still be sued and would have to pay at least the attorney fees. With that said, the Board of Directors, Officers and Special Olympics has decided not to provide alcohol at this event. Letters will be sent out to the participants letting them know of this decision and that they can bring their own beer if desired. Joan reminded everyone that this is our club and we need to participate in it to keep it.

General discussion: Why are folks not coming out to the meetings? What can we do to encourage them to come out and participate? Judy Lindley said that years ago members signed up to call other members to remind them of the meetings. We do put this in the newsletter, on the web-site and in reminder emails already. Doug Foley suggested that we should not have the free pours any more... What is our liability with continuing to do this anyway? We will not be doing this until we have the available monies to do so. We can still have a party on that Saturday, perhaps on the beach, and each person brings their own alcohol if desired. Joan reminded everyone that if we work hard and make enough money off of Fun Monday and the corn hole raffles, then we can pull out of this.

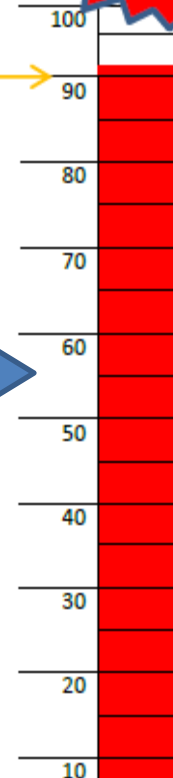

Special Raffle for our shag club.....

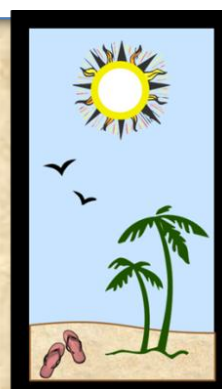
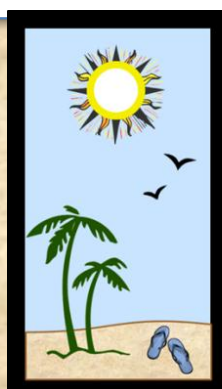
