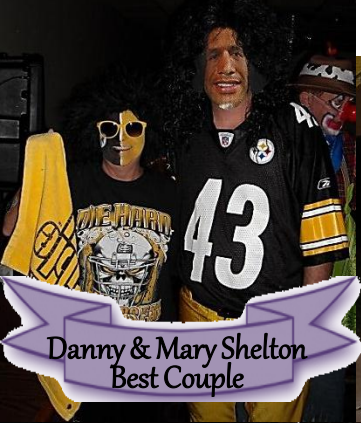

## 5th Annual Shaggin' for Hope

In 2003, Patricia G. Bynum saw a need and began to fill it. She looked past the pain of the cancer diagnosis and saw patients who were also hurting due to struggles to pay their household bills, costs of medications and medical supplies and other basic necessities of life. As she was going through radiation herself, Patricia created a fund to assist those less fortunate patients of the Cancer Center at Alamance Regional Medical Center. Since its beginning, the fund has provided food, gas vouchers, utilities, rent, insurances, taxes, medical and dental care, and more. About a year after she established the fund, Patricia passed away, yet those who remember her still speak of her infectious laugh and compassion for others.



The Patricia Bynum Fund makes it possible for Alamance Regional to minister to patients whose needs transcend the medical care provided. As Coral says, "It's sad but true that some patients are dismissed from their jobs once their short-term disability runs out and they are unable to return." Although they are without an income, their bills still arrive in the mail and their children still need school supplies. For expenses not covered under insurance, the Patricia Bynum Fund may make the difference in a family keeping the roof over their heads and nourishing food in their stomachs.

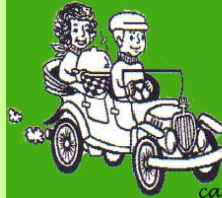

## **Meals on Wheels Annual Breakfast**

I was invited to attend the 40th Anniversary Volunteer Breakfast for Meals on Wheels on October 30, 2012.

This breakfast was held at the First Presbyterian Church in Burlington. The room was filled with volunteers from all walks of life who get up each day and deliver hot meals to citizens of Alamance County who are either elderly, homebound or medically frail. Many of these people have been delivering this food for many years. I listened while they told stories that were funny and others that were humbling, but each brought a sense of pride, as I knew we were also a part of this endeavor. When MOW began in 1973, there were 15 routes – now there are 25 that serve 350 individuals. Greensboro's Golden Corral provides the food to these 350 folks at a cost of about \$3.25 per meal per day. While this food will give them daily nourishment, just the knowledge that someone will be coming to their house each day gives them peace of mind and something to look forward to. Many of the recipients are alone, and a friendly face is all the medicine they need to keep going.

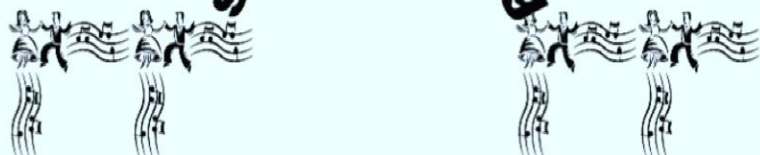

# Special Olympics Award Banquet

A few weeks ago, I was invited to the Alamance County Mayor's Committee for Persons with Disabilities award banquet that was held at Lamb's Chapel in Haw River. It was a very special night for me as everyone there was there because they cared for these persons who were disabled. 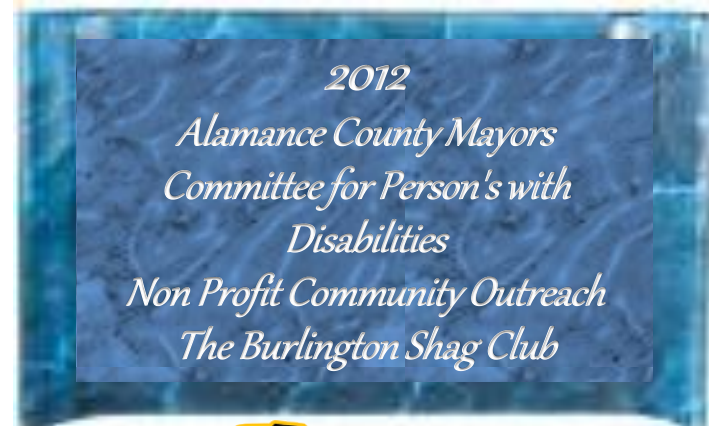

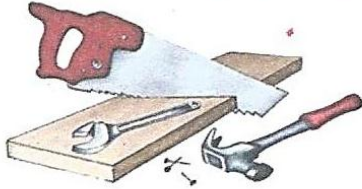
