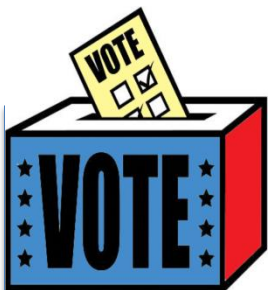

Burlington Shag Club Elections on November 20th will include drive thru voting. Please wear a mask during the entire process.
