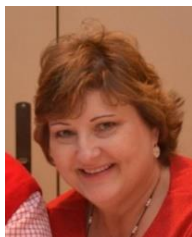

TREASURER'S REPORT - (Jerry Byrd), shared the balances of the General Account and the Fund Raiser Account. These figures were shared with all and any questions were answered. Motion to accept the Treasurer's Report was made by Karen and seconded by Mary. The motion passed.

MONTHLY BUSINESS MEETING - The next business meeting will be September 30, 2022.

BOARD OF DIRECTORS' REPORT – Jack reported that the BOD met August 1, 2022. Committee chairs and future events were discussed. Ways and Means: Budget status and projected upcoming expenses were discussed.

SOS Report – Ron Gregory reported that SOS is on track. Duck's is a part of SOS and it is anticipated that Pirate's Cove is also going to participate. Fun Sunday and Monday will happen. DANCE LESSONS – Darlene reported that Bud Catoe will be teaching Sugarfoot on 8/26 and 9/9, \$5 for members/\$10 for non-members is the cost. Beginner lessons will be offered again after SOS and some line dances, river waltz and stroll.

2022 BENEFIT EVENT – Car Show was August 13 @ Rack and Rolls, 11am-2pm and it was hugely successful. 109 cars entered. Motion was made by Amber to make the Car Show an annual event, it was seconded and passed by the membership. The second event will be held at Woodside Farm for September 10th from 4-10 pm. The theme will be Hibernation Celebration. There will be an afternoon of various contests. Tickets will be \$30, all inclusive. Reservations for a table will be available for \$350. Request these as soon as possible. Furman Dominick will DJ. Food will be BBQ, beans and slaw. September 6 is the food cutoff. Only 3 tables are sold but see Amber to buy tickets. There will be a shuttle to the hotel, Fairfield in Mebane. There will be a raffle for a handgun, 52 tickets available and must be present to win. Bake sale and auction will be held.

COALITION REPORT – Darlene reported the dates for parties for our sister clubs. GTSC will have Fall Frenzy 10/29, Danville's party is November 12th.

SPECIAL FRIDAY PARTY – This will be September 30 and will be a 70's theme. The Margaritaville party will not take place.

Nominations – Jack will be chair of HOF nominations required by October 1st. Buddy/Robin and Scott/Andrea will be the nomination committee chairs for our elections. Do not volunteer for the committee if you plan to run. Nomination forms will be handed out at our September meeting.

Financial Q&A – Darlene gave an overview of what it means to be a 501c7, Social Club. Budget report discussed- About \$8000 is for fixed expenses. Variable expenses are in the budget, but the amount is not set and is about \$6000. Parties usually make money or at least break even. The expenses look like approximately \$14,000. We will keep better records by having a sign in sheet for events and meetings. Ron suggested a way to let members understand where we are at any given moment and gave that to Jerry. It had additional columns on the spreadsheet that is done each month. Darlene discussed the reserve account, and it was suggested that \$7000, 6-month reserve, could be appropriate. The origination of the Fundraising account was explained and whether we need that amount at this time. Jerry voiced that as such a large club, he feels \$100 is too little to pay the DJs. Discussion will continue. Contact the Board for any questions.
