The total of all cash is \$26,804.18. A question was raised about money from a cake being deposited into the general account instead of the fundraising account and Jerry admitted to the error and will correct it. Motion to accept the Treasurer's Report was made by Jack and seconded by Ron. The motion passed.

**BOARD OF DIRECTORS' REPORT** – Jack reported that the BOD met November 7th. Projected upcoming expenses were discussed. Ways and Means were discussed.
